Dear Trumbull Parents and Staff,

The start of the 2021-2022 school year lies just ahead. We have been busy hiring talented staff, cleaning our buildings, and improving curriculum. While I suspect that the school year will face challenges, I am excited that we are returning to 100% in-person learning.

**Vaccine Clinics – Parents, Staff, Eligible Students (12 and up)**

I have been working with Griffin Health to provide vaccine clinics for all eligible students and staff. We recently learned that all school staff are required to be vaccinated against COVID-19 (Executive Order 13D). Below are a listing of the dates for our clinics. Please bring a form of identification. You do not need to sign up in advance of these clinics. The weekday clinics are exclusively for Trumbull students, parents, and staff. There are many [other locations](#) where you may receive your vaccine. The Pfizer vaccine will be provided to those 12 – 18. Adults can receive either the Pfizer or J&J vaccine.

**Adapt, Advance, Achieve – Connecticut’s Plan to Learn and Grow Together – Fall 2021**

The State Department of Education just released its [Fall 2021 guidance](#) for the new school year. While some changes are possible, I wanted to make sure you had the guidance that I just recently received. Please note that Executive Order 13A gives the Commissioner of Education the authority to issue rules related to the required use of masks or face-coverings in school buildings. 
- Ensuring the Physical, Social, and Emotional Well-Being of All Students and Staff
