Recruiting

ON-CAMPUS RECRUITING

Policy Statement

With regard to on-campus recruitment in the Trumbull Public Schools, all recruiters – educational, military, non-military, and commercial – shall be treated uniformly. Military recruiters include representatives of the armed forces of the United States of America and State Armed Services.

Subject to the provisions of federal and state law, high schools shall provide the same directory information and on-campus recruiting opportunities to military recruiters as are offered to non-military recruiters or commercial concerns.

Military recruiters or institutions of higher learning shall have access to secondary school students' names, addresses, and telephone numbers unless the parent/guardian of such student submits a written request that such information not be released without the parent or guardian's prior written consent. A student eighteen years of age or older, rather than his/her parent/guardian, may request in writing that such information not be released without his/her prior written consent. The Board of Education shall notify parents/guardians and students of the option to make such request, and shall comply with any such request received.

The Board of Education shall provide full access to technical high schools, regional agricultural science and technology education centers, interdistrict magnet schools, charter schools, and interdistrict student attendance programs for the recruitment of students attending the schools under the board's jurisdiction, provided such recruitment is not for the purpose of interscholastic athletic competition. The Board shall also post information about these school options on its website. The Board shall inform, at the middle and high school level, students and parents/guardians of the availability of (1) vocational, technical, and technological education and training at technical high schools; and (2) agricultural science and technology education at regional agricultural science and technology education centers.

Regulations

The following guidelines are established to insure that on-campus recruitment of students is conducted in an orderly manner that is not disruptive to the school program:

- 1. Organizations wishing to recruit must make arrangements with the appropriate school principal or designee, who will determine the schedule for the recruitment meeting.
- 2. The number of recruitment meetings for each organization will be determined each academic year by the building principal, but in any case, all recruiters will have an equal opportunity to visit.
- 3. On-campus follow-up meetings with individual student(s) will be permitted only upon the request of the student(s) and with approval of the principal.
- 4. Scheduled visits by recruiters will be made known to the student body by school personnel.
- 5. The school administration reserves the right to deny a recruitment meeting or access request where the holder of such a meeting will materially and substantially interfere with the proper and orderly operation and discipline of the school; is likely to cause violence or disorder; or will constitute an invasion or violation of the rights of other students. Any person or entity denied access under this guideline shall have the right to request a review of the administrative decision by the Board of Education by filing an appropriate written request with the Superintendent of Schools.
